The Organisers and the relevant Sports Partners reserve the right to remove any participant deemed physically incapable (i.e. severe physical harm) of continuing the competition.

### WAIVER / INDEMNITY

I hereby agree to the following terms and conditions of my participation in METTLE GAMES 2011 (hereby refer as the Event).

1. I acknowledged and agreed that:
  - (a) My participation in the Event is entirely voluntary on my own part;
  - (b) I shall receive no payment for my participation in the Event.
2. I have read, understood and accepted the Rules and Regulations applicable to the Event.
3. I have been made fully aware of, and fully understand and acknowledge the risks involved in my participation in the Event. I accept full responsibility and assume all such risks.
